1 1. The parties submit this joint status report regarding *Peruta v. County of*
2 *San Diego*, Ninth Circuit case no. 10-56971, in accordance with the Court’s order
3 of January 19, 2016.

4 2. This Court stayed the case at bar on October 20, 2014, pending the
5 issuance of the mandate in *Peruta*.

6 3. On March 26, 2015, the Ninth Circuit ordered the *Peruta* case to be
7 heard *en banc*, stating that the “three-judge panel opinion [*Peruta v. County of San*
8 *Diego*, 742 F.3d 1144 (9th Cir. 2014)] . . . shall not be cited as precedent by or to
9 any court of the Ninth Circuit.”

10 4. On June 16, 2015, the *Peruta* case was argued and submitted to an *en*
11 *banc* panel of the Ninth Circuit.

12 5. The Status Conference originally scheduled for December 15, 2014,
13 has been continued by the Court, on its own motion, to April 13, 2015, October 13,
14 2015, to January 25, 2016, and to March 28, 2016.

15 6. As of the time of this joint status report, the Ninth Circuit has not
16 issued mandate in *Peruta*.
