JOINT STATUS REPORT

The parties, by and through their respective counsel, hereby submit the following status report regarding this matter:

Since a preliminary injunction was entered in Plaintiff Lenka Knutson's favor on January 25, 2017, Plaintiff Knutson successfully obtained her concealed carry permit. Further, House Bill 273, which allows otherwise-qualified lawful permanent residents to obtain concealed carry permits, was passed by the Legislature, and signed by the Governor on April 7, 2017.

Therefore, the only remaining issue in this matter is that of 42 U.S.C. § 1988 attorney's fees. The parties have agreed that Plaintiffs will file a Fee Petition within 30 days following the filing of this Joint Status Report, unless the parties are able to resolve the issue without seeking court intervention, in which case the parties shall file a Stipulation as to attorney's fees, and subsequent to that the Plaintiffs will file a Motion to Dismiss.
