DECLARATION OF SAMUEL GOLDEN

1. I, Samuel (“Thomas”) Golden, am a plaintiff in the above-entitled action. I make this declaration of my own personal knowledge and, if called as a witness, I could and would testify competently to the truth of the matters set forth herein.

2. I am over the age of 21 and a current resident of Los Angeles County, California.

3. I satisfy all applicable requirements to possess a firearm under state and federal law and currently own a handgun.

4. I am not prohibited from owning firearms under the laws of the United States or the state of California. I have never been found by any law enforcement agency, any court, or any other government agency to be irresponsible, unsafe, or negligent with firearms in any manner.

5. I am a Certified Carry License Instructor for California, Utah, and Florida.

6. I am also one of the trainers qualified to teach the Carry License training course to individuals applying for a Carry License with the Los Angeles County Sheriff. I have trained at least 10,000 shooters at almost every level.

7. I applied with Los Angeles County Sheriff James McDonnell for a Carry License in Los Angeles County, using the California Department of Justice’s standard application form that the Sheriff’s Department provided me. I asserted as my “good cause” a desire to carry a firearm for self-defense, particularly because I had been threatened by multiple individuals who claimed they would easily be able to steal my guns from me.

8. Sheriff McDonnell denied my application for lack of “good cause” because according to the him, I did not face a significant enough threat to warrant a Carry License.

9. I do not currently qualify for any of the exceptions to California’s carry restrictions that would allow me to carry a firearm outside my home for self-defense in some manner.


1 10. I fear that if I am attacked, I will not be able to protect myself, because I
2 cannot lawfully carry a firearm outside my home in any manner.

3 11. I wish to immediately exercise my constitutional right to carry a firearm in
4 public for self-defense, but I am precluded from doing so because I am unable to
5 obtain a license to carry a firearm and California generally prohibits me from
6 carrying a firearm in any manner, openly or concealed, without such a license.

7 12. But for California's comprehensive restrictions on the public carriage of
8 firearms and my inability to obtain a Carry License, I would lawfully carry a
9 firearm in non-sensitive public places for self-defense, but I refrain from doing so
10 for fear of liabilities for violating one or more of California's laws that criminalize
11 my doing so.

12 13. I am thus completely barred from exercising my right to bear arms for
13 self-defense without risking criminal prosecution.

14 I declare under penalty of perjury that the foregoing is true and correct.
